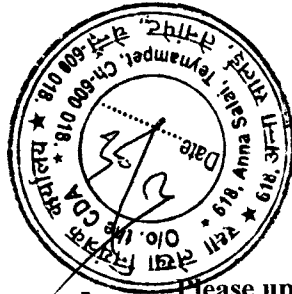
2. In view of above, please intimate the following in respect of Officers/staff of your office:-
